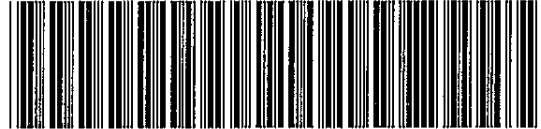

ARTICLE I

NAME

The name of this limited liability company is "McMURRAY AND PRATO HOLDINGS, LLC," referred to in these Articles of Organization as the "Company."

ARTICLE II

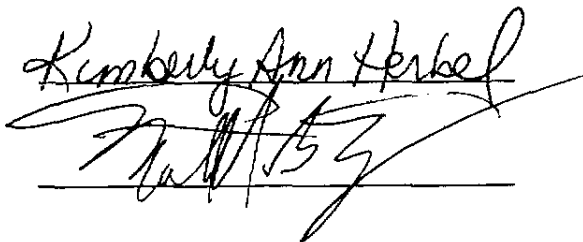

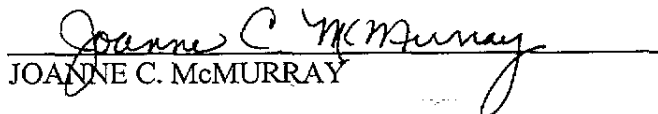

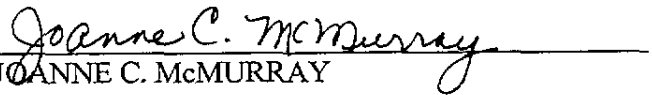
