# ARTICLES OF ORGANIZATION MOORE'S HAPPY ACRES, LLC

The undersigned, pursuant to the provision of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

#### **ARTICLE 1 - NAME**

Members may be admitted to the Limited Liability Company only upon the unanimous agreement of the then existing members.


# **ARTICLE X - CONTINUITY OF BUSINESS**
