



ARTICLES OF ORGANIZATION

RASIK PATEL, L.L.C.

I, the undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby execute this document for the purpose of becoming a limited liability company under the laws of the State of Florida. SECTION OF SECTION

ARTICLE I: NAME

The name of this limited liability company shall be:

ARTICLE II: BUSINESS AND MAILING ADDRESS
