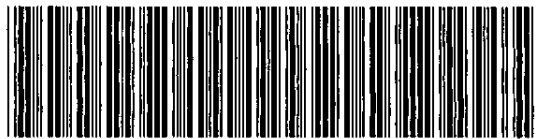

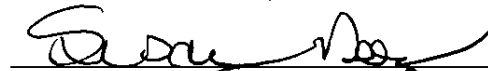

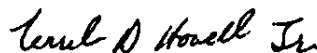
4. Except as amended above, the original Articles of Organization shall remain in full force and effect.
