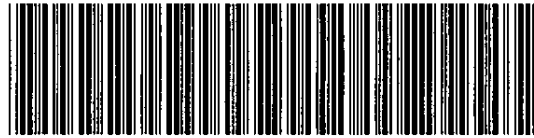



## BILL OF SALE


