ARTICLES OF ORGANIZATION OF

14031 S.W. 143 COURT UNIT 10, LLC

The undersigned hereby executes these Articles for the purpose of forming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. The undersigned further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company").

ARTICLE II

PURPOSE AND POWERS

At the first meeting of the members after the execution of these Articles, the members shall adopt regulations (the "Regulations") containing provisions for the regulation and management of the affairs of the Company, not inconsistent with law or these Articles. The power to adopt, alter, amend or repeal the Regulations shall be vested in the members and shall require their unanimous consent and agreement in regard to any vested right of a member (which shall include any provisions hereof requiring the unanimous approval of the members, any member rights to serve as manager, or rights in the profits, losses, or assets of the Company), or otherwise by a majority vote of the members by percentage Participation.

ARTICLE VI

DURATION AND DISSOLUTION

The Company shall have perpetual existence.

ARTICLE VII

PRINCIPAL PLACE OF BUSINESS

ARTICLE VIII

MANAGEMENT AND MEMBERS

The Company shall be a member managed company and managed by the members. The vote of each member shall be in proportion to the Participation of the member unless otherwise provided in the Regulations.
