**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
FLORIDA VP SANFORD, LLC
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **FLORIDA VP SANFORD, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST:** The Articles of Organization were filed on December 14, 2005, and assigned document number L05000119477.
- SECOND:** Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "**FLORIDA VP SANFORD, LLC**" to "**LIBERTY VP SANFORD, LLC**", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - NAME

The name of this limited liability company is **LIBERTY VP SANFORD, LLC** (the "Company")."

- THIRD:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.
- FOURTH:** The foregoing amendment was adopted by the sole Member of the Company on July 17th 2006..
