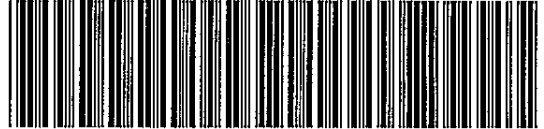

**ARTICLES OF ORGANIZATION

The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be VocalEyes, LLC

ARTICLE II – ADDRESS
