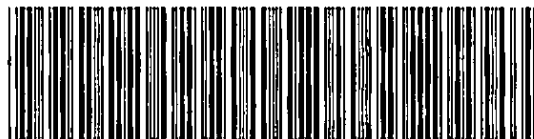



5. This amendment shall be effective on January 1, 2019.



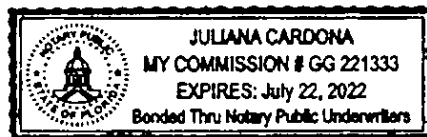
