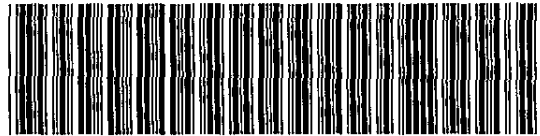

ARTICLES OF ORGANIZATION

OF

COUNTRYSIDE PARK, LLC

The undersigned, desiring to form a limited liability company pursuant to Chapter 608 of the Florida Statutes, executes these Articles of Organization.

ARTICLE I.

The name of the liability company shall be COUNTRYSIDE PARK, LLC

ARTICLE II.

The period of duration of the limited liability company shall be perpetual.

ARTICLE III.

This limited liability company shall be a manager-managed company. The manager of the limited liability company shall be elected by a majority of the members. Robert P. Hudson shall be the initial managing member of this company and shall have complete authority to manage all the

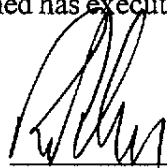

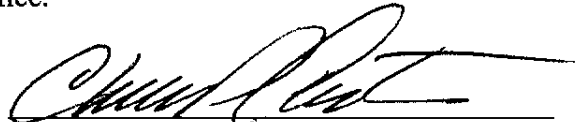
