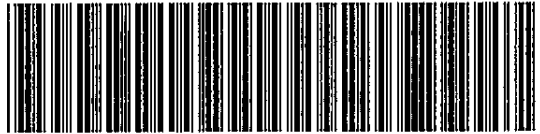

## ARTICLES OF ORGANIZATION OF LIMITED LIABILITY COMPANY

The undersigned, being authorized to execute and file these Articles, hereby certify that:

### ARTICLE I — Name:

The name of the Limited Liability Company is: Wynne Eight, LLC

### ARTICLE II — Address:

### **Article VII— Member's Right to Continue Business**


