MANAGEMENT; MANAGER

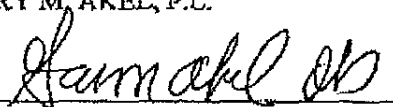

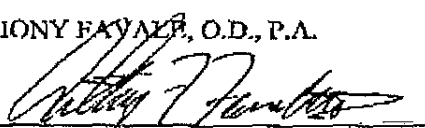
