

### ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

#### **COLLIER ASPEN RIDGE SPE LLC**

FIRST: The Articles of Organization were filed on December 19, 2005, and assigned document number L05000120569.

SECOND: The following amendment to the Articles of Organization was adopted by the limited liability company.

At a meeting of the members of Collier Aspen Ridge SPE LLC held December 23, 2005, at which ti were present and notice was waived, this Amendment was adopted unanimously.

A Sergat 23 3 This Amendment is entered into as of the 23 day of December, 2005, by and among all the Members of Aspen Ridge SPE LLC a Florida limited liability company (the "Company") as an Amendment to the Articles Organization for the Company (the "Articles");

Whereas, The Company's original Articles of Organization were filed on December 19, 2005, with the stated purpose of conducting "any and all lawful business";

Whereas, The Company is the managing member of Collier Aspen Ridge LLC, a Florida limited liability company ("Collier");

Whereas, Collier has assumed, or is about to assume, a first mortgage loan with LaSalle Bank National Association, a national banking association, as Trustee for the registered holders of GE Capital Commercial Mortgage Corporation, Commercial Mortgage Pass-Through Certificates, Series 2002-2, (the "Trust" together with its successors and or/assigns, "Lender").

Whereas, Lender requires that Company be a Special Purpose Entity and requires the addition of certain language in its organizational documents;

Therefore, The Company is deleting the original Article III and replacing the Article with the stated Article below.

#### ARTICLE III Purpose

The purpose for which this Company is organized is limited solely to being the managing member of Collier, acting as, and exercising all of the authority of, the managing member of Collier, and transacting of any and all lawful business for which a company may be organized under its constitutive law that is incident, necessary and appropriate to accomplish the foregoing.
