ARTICLES OF ORGANIZATION

MONSOON COMPANY A, LLC.

The inflersigned, for the purpose of forming a limited liability company pursuant to the Floridal Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Acticles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is MONSOON COMPANY A, LLC.

ARTICLE II - ADDRESS

ARTICLE III - DURATION
