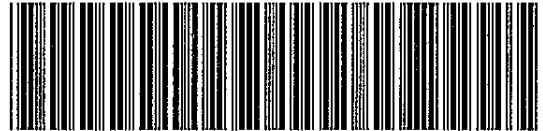

1. The names of the members are:

2. The LLC shall engage in the general business of Advertising and design, as well as operate a Recording Studio.
3. The name of the LLC is Sine Studio, a Florida Limited Liability Company.
4. The LLC will commence on the date the Articles of Organization are filed, and shall continue until 12.29.2019, when it will terminate unless extended by the members.
5. The LLC's principal place of business is 6046 SW 91st PL, Lake Butler, FL 32054.
6. Each member's initial capital contribution to the LLC is:
For Christa Pusateri, the sum of \$600.00, consisting of labor or services previously performed for the LLC.
For Matthew Pusateri, the sum of \$400.00, consisting of non-cash assets of same value.
7. The LLC's profits and Losses shall be shared among the members as follows:
