# ARTICLES OF ORGANIZATION OF PRS OF NAPLES, LLC,

a Florida Limited Liability Company

SOFT TO BE SO SE S The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, add and submit the following Articles of Organization for such limited liability company:

#### ARTICLE I NAME

The name of the limited liability company (the "Company") is PRS OF NAPLES, LLC, a Florida limited liability company.

## ARTICLE II PRINCIPAL PLACE OF BUSINESS

The mailing address and street address of the principal office of the Company shall be 3838 Tamiami Trail North, Suite 402, Naples, Florida 34103.

### ARTICLE III REGISTERED OFFICE AND REGISTERED AGENT

#### ARTICLE V **EFFECTIVE DATE**

The Company's effective date of existence shall begin on the date of filing of these Articles.

#### ARTICLE VI DURATION

The Company's duration shall be perpetual. The Company will be managed by a manager or managers, who shall be designated, appointed or elected as more fully described in the Operating Agreement and Regulations. The number of managers of the Company shall be one (1). The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations. Until such time as a successor or substitute is elected, appointed or designated in accordance with the Operating Agreement and Regulations, the Manager of the Company shall be as follows:
