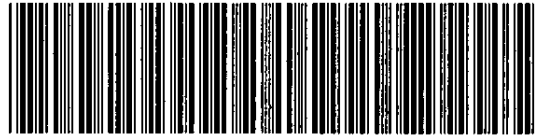



DISTRIBUTION TO MEMBERS**


All the remaining property and assets of the Company have been properly distributed to the Members of the Company in accordance with the respective rights and interests of such Members.
