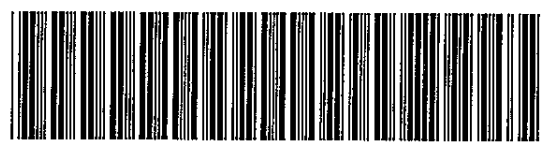

The mailing address and street address of the principal office of the limited liability company is 500 E. Kennedy Blvd., Suite 101-A, Tampa, Florida 33602.

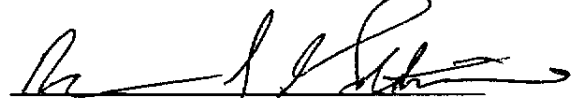
ARTICLE III - Registered Agent & Office:

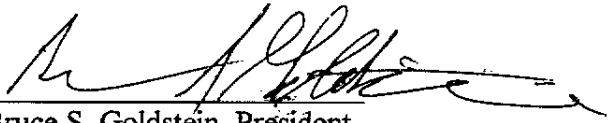
