## ARTICLES OF ORGANIZATION OF NAPLES TRUST PROPERTY VIII, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

#### **ARTICLE I. NAME**

The name of the Limited Liability Company ("Company") shall be Naples Trust Property VIII, LLC.

#### **ARTICLE II. PRINCIPAL PLACE OF BUSINESS**
