The Company shall be a manager managed company. The initial managers shall be:

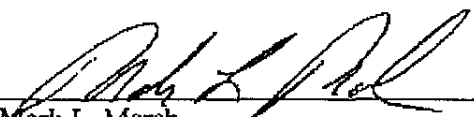

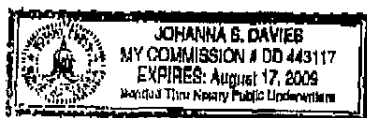

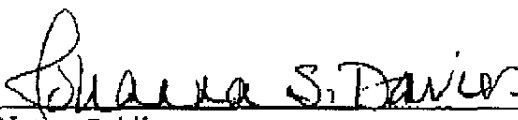
