**ARTICLES OF ORGANIZATION

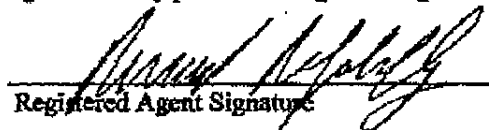

ARTICLE V - REGISTERED OFFICE AND REGISTERED AGENT

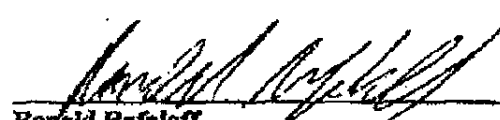
