MAILING AND PRINCIPAL ADDRESS

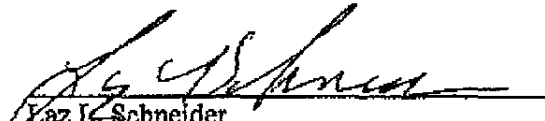
