NAME**

The name of the single member limited liability company is VHP One, LLC, a Single Member Limited Liability Company.

**ARTICLE II
DURATION**

The period of duration for this single member limited liability company is fifty (50) years from the date of filing the Articles of Organization with the appropriate state filing office, unless extended and/or sooner dissolved by the members or as provided by state law.

ARTICLE VI GOVERNING DOCUMENT

The single member limited liability company shall be governed by a written operating agreement, the terms of which shall supplement the provisions of state law. As provided in the operating agreement, the member has permanently and unanimously waived and eliminated, to the maximum extent permitted by law, any liability of the member for the return of money or property to the single member limited liability company which the member rightfully received as a distribution of part or all of the member's capital account.

ARTICLE VII ADMISSION OF ADDITIONAL MEMBERS

Additional members may be admitted to this single member limited liability company only with and upon such terms as are contained in the Operating Agreement and as may be permitted by the law of the state of Florida.

ARTICLE VIII DISCONTINUATION

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of the member or occurrence of any other event, which terminates the continued membership of the member in this limited liability company, the company shall be dissolved in accordance with the law of the state of Florida.

ARTICLE IX MANAGER and MANAGING MEMBER

The business of this single member limited liability company shall be conducted under the exclusive management of its member/manager, who shall have exclusive authority to act for the company in all matters. The member/manager cannot

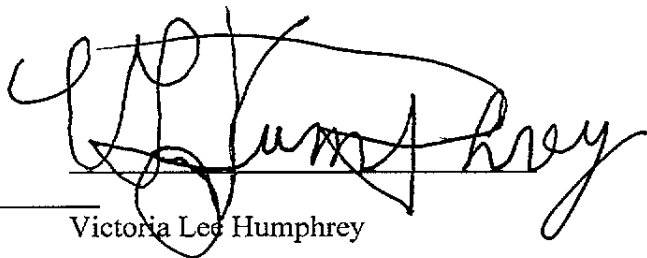

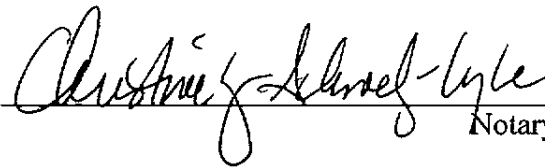

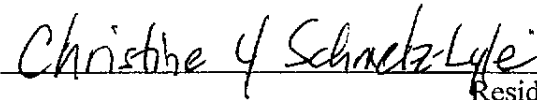
