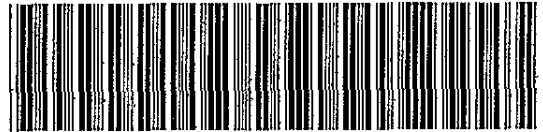

OF

ARTICLE I

Name

The name of the limited liability company is Tile Wholesalers of America, LLC (hereinafter called the "Company").

ARTICLE II

Principal Office
