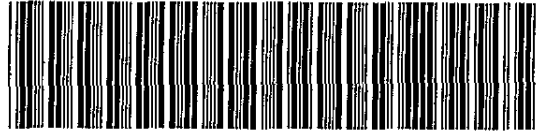

**RE-STATED ARTICLES OF ORGANIZATION  
OF  
TILE WHOLESALERS OF AMERICA, LLC**

**ARTICLE I**

**Name**

The name of the limited liability company is Tile Wholesalers of America, LLC (hereinafter called the "Company").

**ARTICLE II**

**Principal Office**
