ARTICLES OF ORGANIZATION

OF

THE CREDIT ALERT COMPANY, LLC

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges and filed the following Articles of Organization:

ARTICLE L - NAME

The name of the limited liability company shall be: THE CREDIT ALERT COMPANY, LLC ("Company")

ARTICLE II - ADDRESS

ARTICLE VII - ADMISSION OF NEW MEMBERS

All references in these Articles of Organization to "manager," "officer," "employee" and "agonff" shall include their heirs, estates, executors, administrators and personal representatives of such persons.
