**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
LAKE NONA SOUTH IV, LLC  
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, LAKE NONA SOUTH IV, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

**FIRST:** The Articles of Organization of the Company were filed in the name of Lake Nona South IV, LLC, on December 23, 2005, and assigned document number L05000122392.

**SECOND:** Article I of said Articles of Organization is hereby amended in its entirety to change the name of the Company from "LAKE NONA SOUTH IV, LLC" to "NARCOOSSEE ACQUISITION AND DEVELOPMENT, LLC", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE I - Name**

**FOURTH:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.
