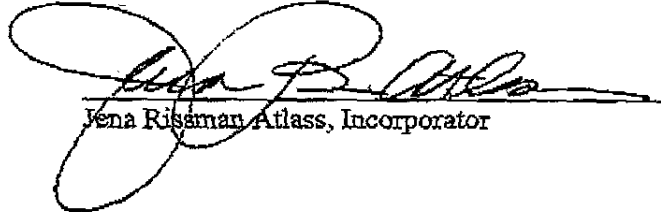
ARTICLE V – INCORPORATION OF THE PROVISIONS OF THE PROFESSIONAL SERVICE CORPORATION ACT

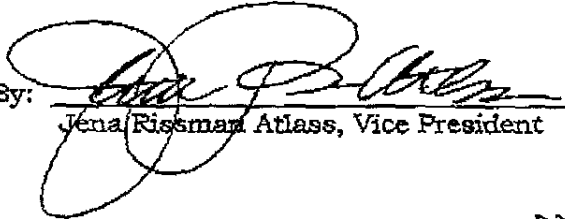
