**SECOND ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LAKE NONA PROPERTY ACQUISITIONS, LLC
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, LAKE NONA PROPERTY ACQUISITIONS, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Second Articles of Amendment:

- FIRST:** The Articles of Organization of the Company were filed in the name of Lake Nona South V, LLC, on December 23, 2005, and assigned document number L05000122398.
- SECOND:** Article I of said Articles of Organization was amended in its entirety to change the name of the Company from "Lake Nona South V, LLC", to "Lake Nona Property Acquisitions, LLC", on October 27, 2006. All other provisions remained unchanged and in full force and effect.
- THIRD:** Article I of said Articles of Organization is hereby further amended in its entirety to change the name of the Company from "LAKE NONA PROPERTY ACQUISITIONS, LLC" to "BEACHLINE PROPERTY ACQUISITIONS, LLC", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - Name

The name of this limited liability company is: "BEACHLINE PROPERTY ACQUISITIONS, LLC (the "Company")."

- FOURTH:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.
- FIFTH:** The foregoing second amendment was adopted by the sole Member of the Company pursuant to approval and execution of that certain Written Consent of Sole Member of even date herewith.
