**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LAKE NONA MYRTLE CREEK, LLC.
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, LAKE NONA MYRTLE CREEK, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

FIRST: The Articles of Organization were filed on December 23, 2005, and assigned document number L05000122408.

SECOND: Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "LAKE NONA MYRTLE CREEK, LLC" to "LAKE NONA CENTRAL, LLC" by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

ARTICLE I - NAME


The name of this limited liability company is LAKE NONA CENTRAL, LLC (the "Company")."

THIRD: All other provisions of the Articles of Organization remain unchanged and in full force and effect.

FOURTH: The foregoing amendment was adopted by the sole Member of the Company on September 1, 2006.
