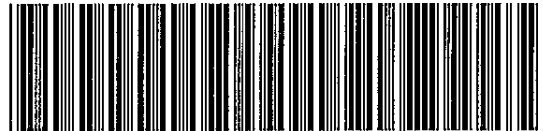

The undersigned, a natural person, does hereby form a Limited Liability Company under Florida Statutes §608, and other laws of the State of Florida.

**ARTICLE 1
NAME**

The name of this limited liability company is GG OF AVENTURA, LLC, referred to in these Articles of Organization as the "COMPANY".

**ARTICLE 2
REGISTERED OFFICE AND AGENT**

The mailing address and the street address of the principal office of the COMPANY is 20380 N. E. 20TH Place, Miami, Florida 33180 and the street address of the COMPANY'S initial registered office is 20380 N. E. 20TH Place, Miami, Florida 33180, and the initial Registered Agent at that address is RICHARD GOIHMAN.

**ARTICLE 3
DURATION**

The existence of the COMPANY shall be perpetual.

**ARTICLE 4
PURPOSE AND POWERS**

Subject to the laws of the State of Florida regarding Limited Liability Companies, the COMPANY may engage in any and all activities and business permitted under the laws of the United States and of the State of Florida. The COMPANY shall have all of the powers vested in a Limited Liability COMPANY organized under and existing by virtue of the laws of the State of Florida.

**ARTICLE 5
MANAGEMENT BY MANAGER(S)**

The COMPANY will be managed by a management committee, consisting of one (1) or more Managers. The Manager(s) will be elected annually by the Members. The number of Managers may be increased or diminished from time to time pursuant to the COMPANY'S Operating Agreement, but shall not be less than one nor more than seven. The Manager(s) will be elected annually by the Members.

**ARTICLE 6

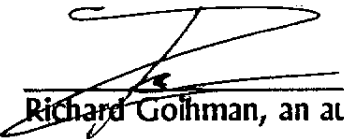
