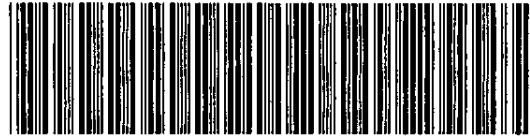


FIFTH: All debts, obligations, and liabilities of the company have been paid or discharged.
