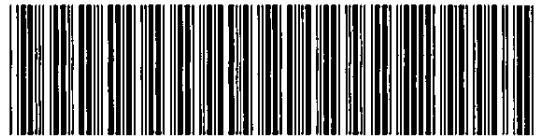

Article VI – Miscellaneous

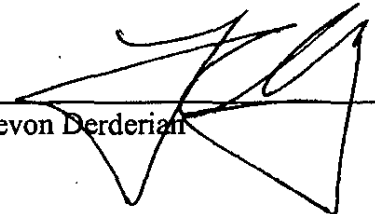
