ARTICLES OF ORGANIZATION
OF
RENAISSANCE RETREAT, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **RENAISSANCE RETREAT, L.L.C.,**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 1859 Northgate Boulevard, Suite 1, Sarasota, Florida 34234.

ARTICLE III - DURATION

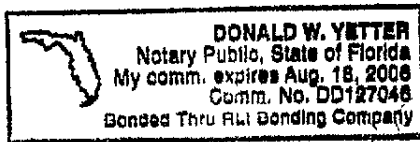
