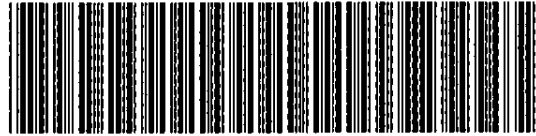

WHEREAS, the date of filing of the Articles of Organization of the Company was December 28, 2005.

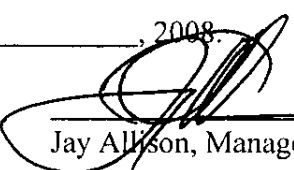
NOW THEREFORE, The Articles of Organization are amended as follows.

2. Except as modified by this Certificate of Amendment, the Articles of Organization and all other terms and conditions shall remain in full force and effect.

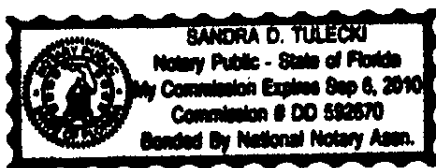

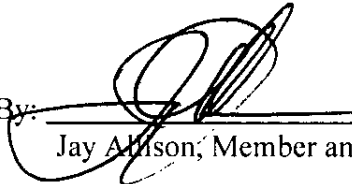

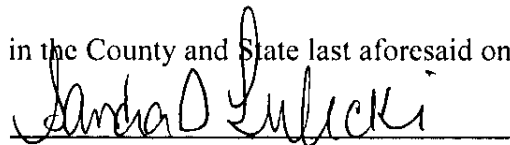
