ARTICLES OF ORGANIZATION

FOR

GARY B. DAVIS FINANCIAL SERVICES, L.L.C.

The undersigned subscriber to these Articles of Organization, desiring to form a Limited Liability Company under the laws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and does hereby adopt the following Articles of Organization as the Charter of the Limited Liability Company hereby organized.

ARTICLE I

NAME

The name of the Limited Liability Company shall be GARY B DAVIS FINANCIAL SERVICES, L.L.C.

<u>ARTICLE II</u>

ADDRESS

ARTICLE III

PURPOSES AND POWERS

- (c) To purchase, lease or otherwise acquire real and personal property and leaseholds thereof and interest therein, and to own, hold, manage, develop, improve, equip, maintain and operate, and to sell, convey, exchange, lease or otherwise alienate and dispose of, and to mortgage, pledge or otherwise encumber any and all such property and any an all legal and equitable rights thereunder and interest therein.
- (d) To borrow or raise money for any of the purposes of the Limited Liability Company and from time to time without limit as to amount to draw, make, accept, endorse, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures and other negotiable and nonnegotiable instruments and evidences of indebtedness; and to secure payment thereof and any interest therein by mortgage, pledge, creation of a security interest, conveyance or other assignment in trust, in whole or part, of the assets of the Limited Liability Company, real, personal or mixed, including contract rights, whether at the time owned or thereafter acquired.
