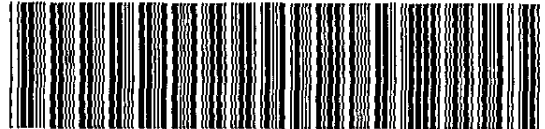

SECOND: The articles of organization for this Company were filed on December 28, 2005 and assigned Document No. L05000122975.


