ARTICLES OF ORGANIZATION OF

NOBLIN FAMILY PROPERTIES, LLC

A FLORIDA LIMITED LIABILITY COMPANY

- 1. <u>Name.</u> The name of the Limited Liability Company is NOBLIN FAMILY, PROPERTIES, LLC, a Florida limited liability company (the "Company").
