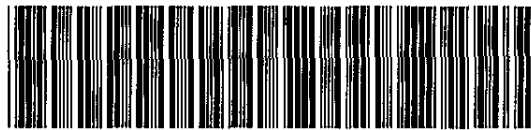


**FIRST:** The Articles of Organization were filed on DEC. 29, 2005 and assigned document number L05000123240.
