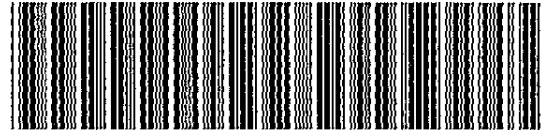

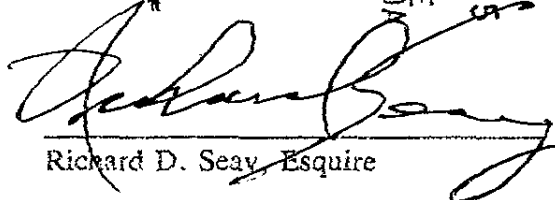

## ARTICLES OF ORGANIZATION

OF

### DDS INVESTMENTS, LLC.

The undersigned, being a natural person of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is: DDS INVESTMENTS, LLC.

SECOND: The Limited Liability Company shall continue perpetually until dissolved or otherwise terminated pursuant to the Limited Liability Company Operating Agreement, or the provisions of Chapter 608 of the Florida Statutes.

THIRD: The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a Limited Liability Company may be organized in accordance with Chapter 608 of the Florida Statutes, including all powers and purposes now and hereafter permitted by law to a limited liability company.

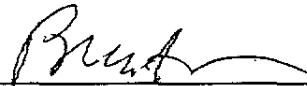
