THE UNDERSIGNED, desiring to amend those Articles of Organization for ART Environmental & Consulting, LLC ("the Company" and "this Company" hereafter), filed on or about 28 December 2005, in order to correct a grammatical/clerical/scriveners error at Article VI. "Management" thereof, and otherwise not correcting, amending or otherwise changing any substantive matter set forth in such Articles, and desiring at the same time to restate such Articles in their entirety for the convenience of the Company in carrying out its business, hereby certifies the following information:

I. ARTICLE 1 - NAME. The name of this Company is:

II. ARTICLE 2 - PURPOSE AND POWERS. The Company shall be organized for the purposes of providing environmental and related consulting services but may conduct any lawful business and shall, consistent with the Act and Company Operating Agreement, have the same powers as an individual to do all things necessary or convenient to carry out the Company's purpose, business and affairs.

III. ARTICLE 3 - DURATION. Upon effectiveness, this Company's term shall be perpetual unless dissolved sooner upon the happening of any mandatory dissolution event as according to the Act or Operating Agreement of the Company.

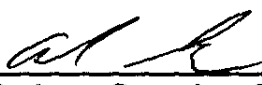
