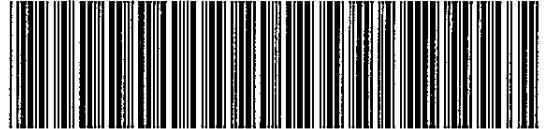

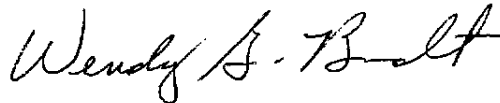

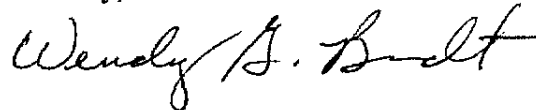

ARTICLES OF ORGANIZATION
OF
CLAY HILLS 301, LLC

The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statute Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **Clay Hills 301, LLC** (the “Company”).

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company is 3269 Doctors Lake Drive, Orange Park, Florida 32068.


ARTICLE III – DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State or on another effective date if specified. 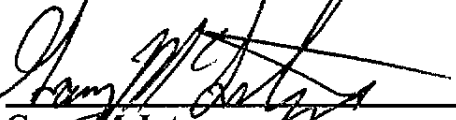

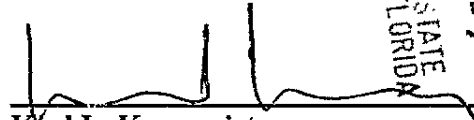
