ARTICLES OF ORGANIZATION

(the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is W & W OF TALLAHASSEE, LLC (hereinafter referred to as the "Company").

PERIOD OF DURATION. 2.
