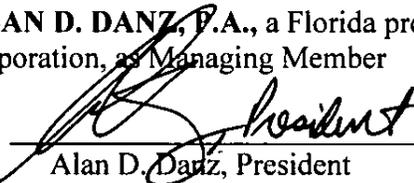
1. The name of the Company is **LIEBERMAN DANZ & KRONENGOLD, P.L.**
