The street address of the principal office of the Company is 4634 Carlton Dunes, #13, Amelia Island, Florida 32034, and the mailing address is the same.

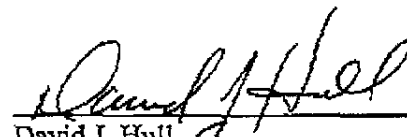

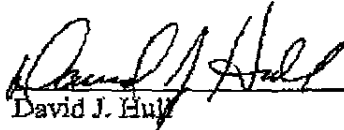
