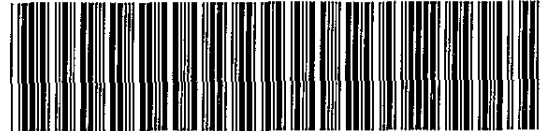


ARTICLE IX
