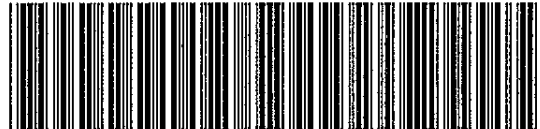

**ARTICLES OF ORGANIZATION**

##### Operating Agreement




