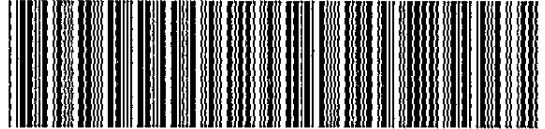

The name of the Limited Liability Company is **DANNY CRAFT, LLC**






