**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
DAVID I. BLOOM, M.D., P.A.**

Pursuant to the provisions of Section 607.1006, *Florida Statutes*, DAVID I. BLOOM, M.D., P.A., a Florida profit corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The following Articles of the Articles of Incorporation are hereby amended to read:

"ARTICLE I - NAME

The name of this corporation is BLOOM & GOMER, M.D., P.A.

ARTICLE X - REGISTERED OFFICE AND AGENT

The street address of the Registered Office of this corporation in the State of Florida shall be 54 N.E. 4th Avenue, Delray Beach, FL 33483. The Board of Directors shall have the power to establish branch offices, and to move the principal office to any other address in Florida.

The Registered Agent for service of process of this corporation, who shall serve until removed by the Board of Directors, is Timothy E. Monaghan, Esq., Strawn, Monaghan & Cohen, P.A., 54 N.E. 4th Avenue, Delray Beach, FL 33483."

2. The effective date of this Amendment shall be upon the filing this Amendment.

3. The date of this amendment's adoption is February 22, 2001.

4. All of the other provisions of the Articles of Incorporation filed with the Secretary of State of Florida on the 31st day of July, 1989, are hereby ratified and confirmed.


5. This amendment was approved by the Board of Directors and the Shareholders of the corporation on February 22, 2001, and the number of votes cast for the amendments were sufficient for approval.

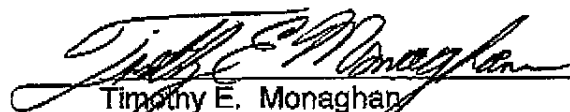
