ARTICLES OF ORGANIZATION OF BAROCO INVESTMENTS, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is BAROCO INVESTMENTS, LLC.

ARTICLE II

The Company's street address of its principal place of business in Florida is 14320 River Road, Pensacola, Florida 32507 and its mailing address is the same, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

ARTICLE III RESTRICTIONS ON MEMBERSHIP

The Member or Members shall have the right to admit new members by unanimous consent. Contributions required of new Members shall be determined as of the time of admission to the Company. ARTICLE IV OPERATING AGREEMENT

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members. An Operating Agreement adopted by the Member or Members may be repealed or altered and a new Operating Agreement pay be adopted by the Member or Members.

ARTICLE V AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the Department of State, and shall be signed and swom to by all Members of the Company.
